### Higher Education Emergency Relief Fund Report – Emergency Financial Aid Grants to Students

January 4, 2021

Gene Juarez Academy (OPE ID: 022033) received education stabilization funds under Section 18004(a)(1) of the Coronavirus Aid, Relief, and Economic Security Act (“CARES Act”), Public Law No: 116-136. This Fund Report applies to the student portion received under the Higher Education Emergency Relief Fund that is designated exclusively for emergency financial aid grants to students.

The institution appreciates that Congress and the President have made these critical funds available for eligible students who have expenses related to the disruption of campus operations due to the coronavirus pandemic. We take receipt of these federal funds seriously and are distributing them in accordance with the CARES Act and implementing guidance.

1. The institution signed and returned to the Department the Certification and Agreement [for] Emergency Financial Aid Grants to Students. The institution has used, or intends to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide emergency financial aid grants to students.
2. The total amount of funds that the institution will receive or has received from the Department pursuant to the institution’s Certification and Agreement [for] Emergency Financial Aid Grants to Students is \$210,200.
3. The total amount of emergency financial aid grants distributed to students under Section 18004(a)(1) of the CARES Act as of the date of this Fund Report is \$210,200.
4. The estimated total number of students at the institution eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965, and thus eligible to receive emergency financial aid grants under Section 18004(a)(1) of the CARES Act, as of the date of this Fund Report is 413.
5. The total number of students who have received an emergency financial aid grant under Section 18004(a)(1) of the CARES Act as of the date of this Fund Report is 156.

### **CARES Act HEERF Policy – Student Portion**

No less than fifty percent (\$210,200) of the CARES Act Higher Education Emergency Relief Fund (HEERF) is to be used to provide emergency financial aid grants to students for expenses related to the disruption of campus operations due to coronavirus, such as food, housing, course materials, technology, health care, and childcare. Gene Juarez Academy is not allowed to use funds from the student portion to reimburse itself.

Only students who are or could be eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 (HEA) may qualify for the Emergency Financial Aid Grant. If a student has successfully filed a Free Application for Federal Student Aid (FAFSA), then the student has demonstrated eligibility. Students who have not filed a FAFSA but who are eligible to file a FAFSA also may receive emergency financial aid grants. The criteria to participate include but are not limited to the following: U.S. citizenship or eligible noncitizen; a valid Social Security number; registration with Selective Service (if the student is male); and a high school diploma, GED, or equivalent; not owe a refund on a federal student grant or be in default on a federal student loan; not have a conviction for the possession or sale of illegal drugs for an offense that occurred while receiving federal student aid. Our enrollment process requires students to submit their Social Security cards as well as proof of high school diploma, GED, or equivalent; copies are retained in the admissions file. Students that have not completed a FAFSA, will submit an attestation regarding their statuses of citizenship, selective service, and drug conviction. Also, for those who have not submitted a FAFSA, Grant and loan history will be checked via NSLDS.

The HEERF allocation will be divided into two portions: initial and supplemental. The initial application will be available to eligible students during a two-week timeframe after Gene Juarez Academy receives the Higher Education Emergency Relief Funds. A supplemental application will be available to eligible students during a one-week timeframe after the initial application process has been completed. If an eligibility attestation is received prior to the deadline but is not accompanied by an application, the applicant will be given an additional 24 hours to complete the application.

For the initial application, only enrolled/active students on 3/13/20, the date of the President's Declaration of National Emergency, will be considered for this grant. Applicants will self-certify on their application that they incurred expenses due to campus disruptions caused by the coronavirus pandemic and that they are financially responsible for at least one of the following categories:

- Food expenses
- Housing expenses
- Expenses associated with technologies for attending online classes
- Health care costs
- Childcare expenses

For the supplemental application, only enrolled/active on 10/31/20 will be considered for this grant. Applicants will self-certify the same information as the initial application. In addition, they will explain, in

essay format, how their financial situation was impacted by the coronavirus pandemic and express their need for an emergency financial aid grant from the supplemental funds.

The amount of each individual emergency financial aid grant will be determined by Gene Juarez Academy (not to exceed \$6,195). There were 247 students enrolled on 3/13/20; 5 students are DACA or undocumented non-citizens therefore, not eligible. \$210,200 divided by the 242 eligible students results in the maximum award of \$868.59 per student.

The award amount for the initial application will be \$800.00. The award amount for the supplemental application will be the remaining portion of the HEERF allocation (\$150,200; \$60,000 was awarded with the initial application) divided by the number of eligible applicants. If the cumulative student emergency financial aid grants exceed the \$210,200 student portion, funds from the institutional portion may be used.

Emergency financial aid grants will be issued to students via check and will not be kept by Gene Juarez Academy to pay outstanding or overdue tuition bills or over-contract fees.

HEERF is not considered federal financial aid under Title IV of the HEA.

Gene Juarez Academy will promptly and to the greatest extent practicable distribute all the HEERF student portion to students by one year from the date of signed certification and document efforts.

Gene Juarez Academy will report to the Secretary 30 days from signed certification and every 45 days after, how grants were distributed, the amount of each grant awarded, how the grant amounts were calculated, any instructions/directions given to the students, and document the Gene Juarez Academy continued to pay all of its employees and contractors during the period of any disruptions or closures to the greatest extent practicable, explaining in detail all specific actions and decisions related.
